Medicare and Hearing Implants



We know the insurance approval process can be overwhelming, so we have provided some information to guide you through the process of obtaining Medicare coverage for hearing implant solutions. The good news is that, unlike hearing aids, hearing implants are typically covered by Medicare and so are the hearing evaluations.*

What you do:

- 1 Have your hearing evaluated by a Hearing Implant Specialist to find out if you are a candidate. We can help you find a Hearing Implant Specialist in your area by visiting www.Cochlear.com/US/Clinic.
- After completing your hearing evaluation, your Hearing Implant Specialist will compare your results with the Medicare coverage criteria to determine your eligibility for coverage under Medicare.
- 3 After confirming your Medicare coverage, the clinic will schedule your next appointment to get a hearing implant solution.

- 1 They will collect your Medicare information.
- Your hearing health professional will verify your benefits and confirm your eligibility for coverage of a hearing implant under your Medicare plan.
- They will work with your Medicare plan to obtain authorization for coverage if it is required under your plan.
