
To participate in the online meeting, visit https://meetnow.global/au.



The webcast will appear automatically once the meeting has started. If the webcast does not start automatically press the play button and ensure the audio on your computer or device is turned on.



To ask a verbal question, follow the instructions on the virtual meeting platform.






To vote, select the 'Vote' icon and the voting options will appear on your screen.


To vote, select the For, Against or Abstain button. A tick will appear to confirm receipt of your vote.
