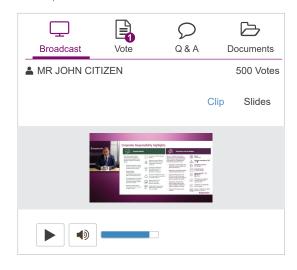

Q & A

Once logged in, you will see the home page which displays the meeting title and name of the registered shareholder or nominated proxy.

The webcast will appear automatically once the meeting has started. If the webcast does not start automatically press the play button and ensure the audio on your computer or device is turned on. Click the 'Clip' or 'Slides' buttons to switch between screens.



To ask a question select the 'Q & A' icon, select the topic your question relates to. Type your question into the chat box at the bottom of the screen and press 'Send'.

Messages can be submitted at any time from the start of the meeting, up until the Chair closes discussion on an item of business.

The Chair will provide shareholders with a reasonable opportunity to ask relevant questions or make relevant comments as each item of business is considered. Written questions may be moderated to avoid repetition and summarised, if particularly lengthy, to streamline the conduct of the meeting.

A telephone line is also available during the meeting for shareholders and proxies who wish to ask a question verbally. To utilise the telephone line, please call Computershare on 1300 855 080 (inside Australia) or +61 3 9415 4000 (outside Australia) **by 10:00am (AEDT) on Thursday 12 October 2023**, to register your participation and obtain the required access code.

Your question will be transcribed by the telephone line operator onto the Computershare online platform as a written question.

Please note, only shareholders and proxies may ask questions on the telephone once they have been verified.
